In the exercise of power conferred under Rule 17 of the Lloyd Trial Advocacy Competition, 2019, the LTAC Organizing Committee, is pleased to notify:

That the participants bearing Enrollment No. LTAC/2019-20/003, LTAC/2019-20/032, LTAC/2019-20/170 have been disqualified from 2nd Lloyd Trial Advocacy Competition 2019-20 on the following grounds:

- i.) That the above mentioned participants have not cleared *prima facie* defects in the Chargesheet even during the extended time. The deadline to submit the chargesheet expired on 02 Nov 2019, 04:30PM.
- ii.) That the above mentioned participants have not filed the Respondent copy of Chargesheet which is mandatory as per the various notifications issued by the Registrar, LTAC.
- iii.) That the Respondent copies are meant to be delivered through the channel of Registry on 03 November 2019 at 09:10AM and non-submission of the respondent copy on time to the Registry will delay in providing the Chargesheet to the Respondent and it violates the principles of Natural Justice.
- iv.) That the abovementioned participants were made aware of the followings through email notifications, LTAC WhatsApp group and also on phone-calls, but these participants have not even cared to go through it.
- v.) That the Registry has given enough time to file the Respondent Copy, i.e. the first deadline expired on 17 October 2019, the second deadline expired on 01 November 2019 and finally the extended deadline expired 02 November 2019.
- vi.) That the above mentioned participants have not even appeared in the Registry to explain the delay and also not moved any special leave application to extend the deadline.
- vii.) That the abovementioned participants have also failed to file an application u/s 207 CrPC which was mandated by Notification - LTAC/2019/Oct/30

viii.) That it is not the 1st occasion that the abovementioned participants have not complied with the L-TAC Rules. The Registry on many occasions has ignored their non-compliance with the L-TAC Rules and subsequent Notifications.

That the abovementioned participants bearing Enrollment No. LTAC/2019-20/003, LTAC/2019-20/032, LTAC/2019-20/170 have been disqualified on the charge of non-compliance with

- ii.) Rule 6 (iv) of the Notification - LTAC/2019/Sept/30,
- iii.) Rule 2(ii), 2(iii) and 2(iv) of the Notification - LTAC/2019/Oct/30,
- iv.) Rule 3 of the Notification - LTAC/2019/Oct/30,
- v.) Rule 6 of the Notification - LTAC/2019/Oct/30, and
- vi.) Rule 5(ii) of the Notification - LTAC/2019/Oct/30

The L-TAC Organizing Committee hereby notifies the disqualification of participants bearing Enrollment No. LTAC/2019-20/003, LTAC/2019-20/032, LTAC/2019-20/170.

The disqualification of the abovementioned participants can be revoked if the L-TAC Registrar gets the respondent copy of the Chargesheet in hard copy in the Registry from 08:30AM - 08:40AM on dated 03 November 2019. Not even a single minute be allowed by the Registrar. The Respondent copy shall be filed by the abovementioned participants in-person and no one shall be authorized on their behalf to file the same. Also, in no case these participants be allowed to clear the *prima facie* defects.
