In the exercise of power conferred under Rule 21 of the Lloyd Trial Advocacy Competition, 2019, the LTAC Organizing Committee, is pleased to notify the followings:

1. SUPPLEMENTARY CHARGESHEET

- i.) Participants are allowed to file Supplementary Chargesheet to the Registry latest by 08th November 2019, 04:00 PM. The Registry is directed to no take any chargesheet beyond this time.
- ii.) The Supplementary Chargesheet shall be treated as filed only if it is filed in hard copy and the record is registered in the Register maintained by the Registrar for that purpose.
- iii.) There shall be filed 1 original and 2 duplicate copy.
- iv.) There shall not be any substantive change in the supplementary chargesheet that contradict the Main Chargesheet. The supplementary chargesheet shall only be supplementary and not the substitutive.
- v.) The supplementary chargesheet shall not be evaluated. However, any supplementary chargesheet missing the page No., Index, supplementary chargesheet form will attract negative marking.
- vi.) The Registry is directed to strictly follow the timings and to close the Registry after the deadline.

2. MISCELLANEOUS APPLICATIONS

- i.) The Miscellaneous Application/Petition can be filed latest by 11th November 2019, 04:00PM.
- ii.) The miscellaneous application shall be treated as filed only if it is filed in hard copy and the record is registered in the Register maintained by the Registrar for that purpose.
- iii.) There shall be filed 1 original and 2 duplicate copy.
- iv.) The matter shall be listed by the Registrar as per his convenience in discussion with the designated judges of the L-TAC.
- v.) The application/petition may be rejected by the Registrar if all the documents are not attached, or if there are any defects in it. In no case, the Registry shall be open to file the rejected application after the deadline.
- vi.) The dates entered into the Register shall be the date of filing.
- vii.) Rule 2 and 3 of Notification - LTAC/2019/Sept/30 shall be read as the part of this Notification.
