1. RESULT - ELIMINATION ROUND 1

- i.) The Result of Elimination Round 1 has been prepared and is declared through this Notification, as annexure A.
- ii.) The Result is prepared after evaluating the FIR, Rukka, Report u/s 157 CrPC, *Prima Facie* Defects in Chargesheet, Final Report leading to Chargesheet, Miscellaneous Applications, Penalty for not attending workshops or for not submitting the documents on the time.
- iii.) The Score-sheet of evaluation is not disclosed to anyone. Only the participants who has been either disqualified or eliminated can approach the Organizing Committee in case of any doubt.

2. PRIMA FACIE DEFECTS
