In the exercise of power conferred under Rule 21 of the Lloyd Trial Advocacy Competition, 2019, the LTAC Organizing Committee, is pleased to notify the followings:

SUBMISSION OF RUKKA, F.I.R, REPORT u/s 157 Cr.P.C etc.:

All the participants were supposed to submit their Rukka, F.I.R and Report u/s 157 of Cr.P.C etc. according to specified dates in the hard copy. The LTAC-Registrar in consultation with Organizing Committee opens the online portal of Registry to submit "Rukka, F.I.R., Report u/s 157 of Cr.P.C, Arrest Memo and Application for remand" by scanning the document and sending it to LTAC Email ID i.e. ltac@lloydcollege.edu.in. The detailed guidelines are mentioned below:

1. RUKKA:

The participants can submit their Rukka by scanning it and sending it to LTAC Email ID before 11:59 PM on 10th September, 2019. No relaxation will be given to any participant for whatsoever reason it may be. Whoever will be submitting the online copy have to submit the original copy (i.e. the hardcopy of the Online Submission) of Rukka by 15th September, 2019 before 2:30 PM.

Explanation: There shall be no discrepancy between the scanned copy and original copy. For instance, even a minor change such as removing of punctuation mark will attract negative marking and the decision of Evaluation Committee shall be final. The Rukka once submitted (whether online or offline), no amendments shall be treated.

2. F.I.R:

The participants can submit their F.I.R by scanning it and sending it to LTAC Email ID before 11:59 PM on 11th September, 2019. No relaxation will be given to any participant for whatsoever reason it may be. Whoever will be submitting the online copy have to submit the original copy (i.e. the hardcopy of the Online Submission) of F.I.R. by 15th September, 2019 before 2:30 PM.

Explanation: There shall be no discrepancy between the scanned copy and original copy. For instance, even a minor change such as removing of punctuation mark will attract negative marking and the decision of evaluation committee shall be final. The F.I.R. once submitted (whether online or offline), no amendments shall be treated.

3. Report u/s 157 of Cr.P.C:

The participants can submit their Report u/s 157 of Cr.P.C by scanning it and sending it to LTAC Email ID before 11:59 PM on 11th September, 2019. No relaxation will be given to any participant for whatsoever reason it may be. Whoever will be submitting the online copy have to submit the original copy (i.e. the hardcopy of the Online Submission) of Report u/s 157 Cr.P.C. by 15th September, 2019 before 2:30 PM.

Explanation: There shall be no discrepancy between the scanned copy and original copy. For instance, even a minor change such as removing of punctuation mark will attract negative marking and the decision of evaluation committee shall be final. The Report u/s 157 once submitted (whether online or offline), no amendments shall be treated.

4. ARREST MEMO:

The participants can submit "Arrest Memo" (if any) by scanning it and sending it to LTAC Email ID or in hard copy to the Registry within 24 hours from the time when the accused is arrested by the police. No relaxation will be given to any participant for whatsoever reason it may be otherwise this ground can be used by defense counsel against you as per the criminal law.

Explanation: There shall be no discrepancy between the scanned copy and original copy. For instance, even a minor change such as removing of punctuation mark will attract negative marking and the decision of evaluation committee shall be final. The Arrest Memo once submitted (whether online or offline), no amendments shall be treated.

5. Application for remand:

The participants can submit the Remand Application pursuant to the Arrest by scanning it and sending it to LTAC Email ID or in hard copy to the Registry within 18 hours from the time when the application is made by the police. No relaxation will be given to any participant for whatsoever reason it may be.

Explanation: There shall be no discrepancy between the scanned copy and original copy. For instance, even a minor change such as removing of punctuation mark will attract negative marking and the decision of evaluation committee shall be final. The Application for Remand once submitted (whether online or offline), no amendments shall be treated.

ADDITIONAL RULES AND GUIDELINES:

1. Whoever fails to send any document as per above mentioned direction shall be awarded deduction of marks by the Evaluation Committee as it deem fit and proper.
2. All the Memos, Report, Application etc. prepared by the police or Lawyer shall be in English language only.
3. Any document that the police recover during the investigation can be in Hindi language, depending on the facts of the case.
4. If police want to record Dying Declaration of any person or to get recorded the statement of any person u/s 164 Cr.P.C, or for Test Identification Parade etc. he shall approach the L-TAC Registry and file the application and required documents as per the Court Rules, then a Magistrate from the Registry will record the same. The magistrate will after recording the statement shall sign, stamp and mark the date on which the statement is recorded.
5. For attesting of any affidavit, Registry can be approached.
6. For any other stamps eg. Police stamp, FSL, CDR or any such other documents, participants can make their own stamps, but in no case the Registry shall be approached.
7. If any participant is unable to physically come to the Registry for filing, he can authorize his friend to file the same subject to the submission of authority letter to the Registry (either through mail or hard copy). The friend must carry his/her ID Card.
