**Notification - LTAC/2019/Sept/30**

In the exercise of power conferred under Rule 21 of the Lloyd Trial Advocacy Competition, 2019, the LTAC Organizing Committee, is pleased to notify the followings:

**1. MISCELLANEOUS APPLICATIONS**

- i.) The miscellaneous application shall be treated as filed only if it is filed in hard copy and the record is registered in the Register maintained by the Registrar for that purpose.
- ii.) There shall be filed 1 original and 2 duplicate copy.
- iii.) The matter shall be listed by the Registrar as per his convenience in discussion with the designated judges of the L-TAC.
- iv.) The application/petition may be rejected by the Registrar if all the documents are not attached, or if there are any defects in it.
- v.) The dates entered into the Register shall be the date of filing.

**2. MANDATORY DOCUMENTS TO BE FILED**

The followings are the documents that have been mandated by the Registrar for filing of any application/petition to the Registry. The Registrar may require additional documents to be filed in any or all application/petition if he may feel it necessary.

**3. COMMON DEFECTS**

The Registrar may reject the application/petition solely on the below mentioned grounds.

- i.) Court Fee not paid in Application, Affidavit or/and Vakalatnama.
- ii.) Affidavit without name, father's name, age or/and residence.
- iii.) Pages are not numbered.
- iv.) The duplicate copies are not in order in the way the original copy is.
- v.) All the documents are not attached.

- vi.) Grounds are not mentioned in Petition to the High Court.
- vii.) Jurisdiction is not satisfied.
- viii.) Court Name, Matter name is incorrect.
- ix.) Date, place, FIR No., Police Station name are not mentioned.
- x.) Any other defect.

**4. LAST DATE TO FILE THE DOCUMENTS**

- i.) The last date to file the Arrest Memo is 5<sup>th</sup> October 2019. The Arrest Memo is to be filed Online only.
- ii.) The last date to file the Petition before the High Court in hard copy is 6<sup>th</sup> October 2019. Provided that where the name of the accused is disclosed between 3<sup>rd</sup> - 5<sup>th</sup> October, the Petition to the High Court can be filed latest by 7<sup>th</sup> October 2019.
- iii.) The last date to file the Bail Application is 6<sup>th</sup> October 2019. Provided in cases where the accused is arrested between 3<sup>rd</sup> - 5<sup>th</sup> October, the defense counsel can file the bail application latest by 8<sup>th</sup> October 2019. The application shall be filed in hard copy.
- iv.) The last date to file application for recording of statement under section 164 CrPC is 8<sup>th</sup> October 2019. The application shall be filed Online.
- v.) In no case, any kind of miscellaneous application/petition can be filed after 8<sup>th</sup> October unless it is approved by Registrar on special circumstances. Provided that the prior permission from Prof. Rupesh Singh shall be taken by the applicant.

**5. ORDER TO SEND THE ACCUSED IN JUDICIAL CUSTODY.**

- i.) In the cases where the Police Custody is expired, it shall be deemed that the said accused is/are sent to Judicial Custody by the Order of Magistrate for 14 days from that day.
- ii.) After the expiry of Judicial Custody when expired, it shall be deemed that the said accused is/are are sent to Judicial Custody for further 14 days and so on.
- iii.) This clause shall have retrospective effect.

**6. FILING OF FINAL REPORT LEADING TO CHARGESHEET**

- i.) The last date to file the Chargesheet is 17<sup>th</sup> October 2019. Only one copy is to be submitted by the participant that shall not be returned to him.
- ii.) The Chargesheet submitted on 17<sup>th</sup> October 2019 shall be evaluated for final marks.
- iii.) The Registrar shall notify the defects in the Chargesheet after checking it and the list of defects shall be notified to the participant.
- iv.) The Participant shall have to clear the defects and file the Final Report leading to Chargesheet latest by 1<sup>st</sup> November 2019. There shall be filed 3 copies.

**7. 1<sup>st</sup> ELIMINATION ROUND**

- i.) All the selected participants shall have to submit their Chargesheet by 17<sup>th</sup> October 2019.
- ii.) The Registrar shall notify the prima-facie defects by 23<sup>rd</sup> October 2019.
- iii.) The Organizing Committee shall declare the result of Round 1 by 30<sup>th</sup> October.
- iv.) Only the 36 participants selected in Round No. 1 via Merit List declared on or by 30<sup>th</sup> October 2019 shall file the 3 copies of Final Chargesheet on 1<sup>st</sup> November 2019.

**8. WHATSAPP GROUP**

L-TAC WhatsApp group had been created on 2<sup>nd</sup> September 2019. Many notifications are being given on it. Those who are not in the group can contact the Organizing Committee and request to add them.

**9. STAMPING**

- i.) Participants can get the documents stamped by the Registry where it is necessary. The report u/s 157, Remand Application, Application to record statement u/s 164 CrPC, Affidavits, Affidavit u/s 65B IT Act and other related documents can be stamped by the Registry.
- ii.) Wherever the stamping of Police Station, Investigating Officer, FSL, MLC or related documents is required, the participants have to stamp it by their own. After filing of Chargesheet on 17<sup>th</sup> October, no participant shall be allowed to stamp any document.
- iii.) For the purpose of clause 9(ii), Digital stamping is also a valid stamping.

**10. ORIGINAL FIR, Rukka, and Report u/s 157 and other documents**

The participants shall file the duplicate copy of FIR, Rukka and Report u/s 157 in the Chargesheet that is to be submitted on 17<sup>th</sup> October 2019. The Organizing Committee itself will replace those duplicate FIR, Rukka and Report with the Original ones that were submitted earlier to the Registry.
